# TWO EXTRAPOLATION THEOREMS FOR RELATED WEIGHTS AND APPLICATIONS 

M. Lorente and M.S. Riveros


#### Abstract

In this paper we prove two extrapolation theorems for related weights. The theorems proved by C. Segovia and J.L. Torrea in [C. Segovia and J.L. Torrea, Weighted inequalities for commutators of fractional and singular integrals. Publ. Mat. 35 (1991) 209-235] are adapted for one-sided weights. We apply these extrapolation theorems to improve weighted inequalities for commutators (with symbol $b$ depending on the related weights) of several one-sided operators such as the Weyl and the Riemann-Liouville fractional integrals, or one-sided maximal operators given by the convolution with a smooth function. We also characterize the symbols $b$ for which the commutators of these one-sided operators are bounded.


## 1. Introduction

Extrapolation theorems have been a very useful tool in Harmonic Analysis. Rubio de Francia developed extrapolation technics for the $A_{p}$ Muckenhoupt classes of weights in 1984 ([16]). Several authors had obtained generalizations of these results or had adapted his technics to solve a great kind of several problems referring to weighted inequalities (see [5], [6], [11], [18], [9], [3]).

In this paper we prove two extrapolation theorems for related weights. Before stating the results we need some definitions. Throughout this paper the letter $C$ will be a positive constant, not necessarily the same at each occurrence and $M$ will be the Hardy-Littlewood maximal function, $M f(x)=\sup _{h>0} \frac{1}{2 h} \int_{x-h}^{x+h}|f|$. If $1 \leq p \leq \infty$, then its conjugate exponent will be denoted by $p^{\prime}$ and $A_{p}$ will be the classical Muckenhoupt class of weights (see [14]). Also, given an interval $I=(x, x+h), h>0$, we will denote by $I^{+}=(x+h, x+2 h)$ and $I^{-}=(x-h, x)$.
Definition 1.1. The one-sided Hardy-Littlewood maximal operators $M^{+}$ and $M^{-}$are defined for locally integrable functions $f$ by

$$
M^{+} f(x)=\sup _{h>0} \frac{1}{h} \int_{x}^{x+h}|f|, \quad \text { and } \quad M^{-} f(x)=\sup _{h>0} \frac{1}{h} \int_{x-h}^{x}|f| .
$$

[^0]The good weights for these operators are the one-sided weights, $A_{p}^{+}$and $A_{p}^{-}$:

$$
\begin{gather*}
\sup _{a<b<c} \frac{1}{(c-a)^{p}} \int_{a}^{b} \omega\left(\int_{b}^{c} \omega^{1-p^{\prime}}\right)^{p-1}<\infty, \quad 1<p<\infty  \tag{p}\\
M^{-} \omega(x) \leq C \omega(x) \quad \text { a.e. } \tag{1}
\end{gather*}
$$

and

$$
\begin{equation*}
A_{\infty}^{+}=\cup_{p \geq 1} A_{p}^{+} \tag{+}
\end{equation*}
$$

The classes $A_{p}^{-}$are defined in a similar way. It is interesting to note that $A_{p}=A_{p}^{+} \cap A_{p}^{-}, A_{p} \subsetneq A_{p}^{+}$and $A_{p} \subsetneq A_{p}^{-}$. Also $w \in A_{p}^{+}$if and only if $w^{1-p^{\prime}} \in A_{p^{\prime}}^{-}, 1<p<\infty$. (See [17], [10], [11], [12] for more definitions and results.)
Definition 1.2. The one-sided maximal fractional operator $M_{\gamma}^{+}, 0<\gamma<$ 1 , is defined, for locally integrable functions $f$, by

$$
M_{\gamma}^{+} f(x)=\sup _{h>0} \frac{1}{h^{1-\gamma}} \int_{x}^{x+h}|f| .
$$

It is proved in [2] that $\left\|M_{\gamma}^{+} f\right\|_{L^{q}\left(w^{q}\right)} \leq C\|f\|_{L^{p}\left(w^{p}\right)}$ if and only if $w \in$ $A^{+}(p, q)$, for $1<p<1 / \gamma, 1 / p-1 / q=\gamma$, where
$\left(A^{+}(p, q)\right) \quad\left(\frac{1}{h} \int_{x-h}^{x} \omega^{q}\right)^{1 / q}\left(\frac{1}{h} \int_{x}^{x+h} \omega^{-p^{\prime}}\right)^{1 / p^{\prime}} \leq C$,
$\left(A^{+}(p, \infty)\right) \quad\left\|\omega \chi_{[x-h, x]}\right\|_{\infty}\left(\frac{1}{h} \int_{x}^{x+h} \omega^{-p^{\prime}}\right)^{1 / p^{\prime}} \leq C$,
for all $h>0$ and $x \in \mathbb{R}$. The classes $A^{-}(p, q)$ are defined in a similar way and also observe that $A(p, q)=A^{+}(p, q) \cap A^{-}(p, q)$, for all $1 \leq p<\infty$ and $1<q \leq \infty$.

Now we are ready to state the extrapolation results.
Theorem 1.1. Let $\nu$ be a weight and $T$ a sublinear operator defined in $\mathcal{C}_{c}^{\infty}(\mathbb{R})$ (the set of $\mathcal{C}^{\infty}$ functions with compact support) and satisfying

$$
\|\beta T f\|_{\infty} \leq C\|f \alpha\|_{\infty}
$$

for all $\beta$ and $\alpha$, such that $\alpha=\nu \beta, \beta^{-1} \in A_{1}^{-}$and $\alpha^{-1} \in A_{1}$.
Then, for $1<p<\infty$,

$$
\|T f\|_{L^{p}(w)} \leq C\|f\|_{L^{p}(v)},
$$

holds whenever $w \in A_{p}^{+}$and $v=\nu^{p} w \in A_{p}$.

Theorem 1.2. Let $\nu$ be a weight, $p_{0}>1$ and $T$ be a sublinear operator defined in $\mathcal{C}_{c}^{\infty}(\mathbb{R})$ such that

$$
\|\beta T f\|_{\infty} \leq C| | f \alpha \|_{p_{0}}
$$

for all $\beta, \alpha$, such that $\beta \in A^{+}\left(p_{0}, \infty\right)$ and $\alpha=\nu \beta \in A\left(p_{0}, \infty\right)$.
Then, if $1<p<p_{0}$ and $q$ is such that $\frac{1}{p}-\frac{1}{q}=\frac{1}{p_{0}}$, the inequality

$$
\|T f\|_{L^{q}\left(w^{q}\right)} \leq C\|f\|_{L^{p}\left(v^{p}\right)}
$$

holds whenever $w \in A^{+}(p, q)$ and $v=\nu w \in A(p, q)$.
In section 2 we state and prove several applications for these theorems, and in section 3 we give the proof of the extrapolation results.

## 2. Applications

First we give some definitions.
Definition 2.1. For $b \in L^{1}(\mathbb{R})$ and $\nu \in A_{\infty}$, we say that $b \in B M O_{\nu}$ if

$$
\|b\|_{B M O_{\nu}}=\sup _{I} \frac{1}{\nu(I)} \int_{I}\left|b-b_{I}\right|<\infty
$$

where $I$ denotes any bounded interval and $b_{I}=\frac{1}{|I|} \int_{I} b$. (For $\nu=1$ we get the classical BMO space.)

Observe that $b \in B M O_{\nu}$ if and only if $\sup _{I} \frac{1}{\nu(I)} \int_{I}\left|b-b_{I^{+}}\right|<\infty$, or equivalently, $\sup _{I} \frac{1}{\nu(I)} \int_{I \cup I^{+}}\left|b-b_{I^{+}}\right|<\infty$.

Definition 2.2. Let $f$ be a locally integrable function. The one-sided sharp maximal function is defined by

$$
f_{\#,+}(x)=\sup _{h>0} \frac{1}{h} \int_{x}^{x+h}\left(f(y)-\frac{1}{h} \int_{x+h}^{x+2 h} f\right)^{+} d y
$$

It is proved in [13] that

$$
\begin{aligned}
f_{\#,+}(x) & \leq \sup _{h>0} \inf _{a \in \mathbb{R}} \frac{1}{h} \int_{x}^{x+h}(f(y)-a)^{+} d y+\frac{1}{h} \int_{x+h}^{x+2 h}(a-f(y))^{+} d y \\
& \leq C\|f\|_{\text {BMO }} .
\end{aligned}
$$

Definition 2.3. Let $0<\gamma<1$. The Weyl fractional integral is defined by

$$
I_{\gamma}^{+} f(x)=\int_{x}^{\infty} \frac{f(y)}{(y-x)^{1-\gamma}} d y
$$

and, for appropriate $b$, the commutator of the Weyl fractional integral is defined by

$$
I_{\gamma, b}^{+} f(x)=\int_{x}^{\infty}(b(x)-b(y)) \frac{f(y)}{(y-x)^{1-\gamma}} d y
$$

We shall also use for our purposes the following variant of the one-sided Hardy-Littlewood maximal operator:

Definition 2.4. For $\varphi \in \mathcal{C}_{c}^{\infty}(-\infty, 0], \varphi \geq 0$ and nondecreasing in $(-\infty, 0]$, let $\varphi_{\varepsilon}(x)=\varepsilon^{-1} \varphi\left(\varepsilon^{-1} x\right)$ for $\varepsilon>0$. The maximal operator associated to $\varphi$ is defined as

$$
M_{\varphi}^{+} f(x)=\sup _{\varepsilon>0} \varphi_{\varepsilon} *|f|(x)
$$

It is not difficult to see that $M_{\varphi}^{+} f$ is pointwise equivalent to $M^{+} f$. Now we define the commutator for this maximal operator.

Definition 2.5. Let $\varphi$ be as in definition 2.4. For appropriate $b$, the commutators of $M_{\varphi}^{+}$and $M^{+}$, are

$$
M_{\varphi, b}^{+} f(x)=\sup _{\varepsilon>0} \int_{x}^{\infty}|b(x)-b(y)| \varphi_{\varepsilon}(x-y)|f(y)| d y
$$

and

$$
M_{b}^{+} f(x)=\sup _{h>0} \frac{1}{h} \int_{x}^{x+h}|b(x)-b(y)||f(y)| d y
$$

Now we will give the definition of another maximal fractional operator.
Definition 2.6. Let $0<\gamma<1$. Suppose $\varphi_{\gamma} \in \mathcal{C}^{\infty}((-\infty, 0]), \varphi_{\gamma} \geq 0$, nondecreasing in $(-\infty, 0]$ and such that $\left|\varphi_{\gamma}(x-y)-\varphi_{\gamma}(x)\right| \leq C|y||x|^{\gamma-2}$, for all $x, y$ such that $|x|>2|y|$. The maximal operator associated to $\varphi_{\gamma}$, is defined by

$$
M_{\varphi_{\gamma}}^{+} f(x)=\sup _{\varepsilon>0} \varphi_{\gamma, \varepsilon} *|f|(x)
$$

Definition 2.7. Let $\varphi_{\gamma}$, as in definition 2.6. For appropriate $b$, the commutators of $M_{\varphi_{\gamma}}^{+}$and $M_{\gamma}^{+}$, are

$$
M_{\varphi_{\gamma}, b}^{+} f(x)=\sup _{\varepsilon>0} \int_{x}^{\infty}|b(x)-b(y)| \varphi_{\gamma, \varepsilon}(x-y)|f(y)| d y
$$

and

$$
M_{\gamma, b}^{+} f(x)=\sup _{h>0} \frac{1}{h^{1-\gamma}} \int_{x}^{x+h}|b(x)-b(y)||f(y)| d y
$$

Now we are ready to state the boundedness results for the operators just defined. The proofs are based on the extrapolation theorems of section 1.

In the next theorem we get a boundedness result for the commutator of $M_{\varphi}^{+}$.
Theorem 2.1. Let $\varphi$ be as in definition 2.4. Assume that $1<p<\infty$, $v \in A_{p}, w \in A_{p}^{+}$are such that $\nu=\left(\frac{v}{w}\right)^{1 / p} \in A_{\infty}$. Then, for $b \in B M O_{\nu}$, there exists $C>0$ such that

$$
\int_{\mathbb{R}}\left|M_{\varphi, b}^{+} f\right|^{p} w \leq C \int_{\mathbb{R}}|f|^{p} v
$$

for all bounded $f$ with compact support.
In the following theorem we get a boundedness result for the commutator of the one-sided fractional integral.

Theorem 2.2. Let $\gamma, p, q$ be such that $0<\gamma<1,1<p<\frac{1}{\gamma}$ and $\frac{1}{p}-\frac{1}{q}=$ $\gamma$. Assume that $v \in A(p, q), w \in A^{+}(p, q)$ are such that $\nu=\frac{v}{w} \in A_{\infty}$. Then, for $b \in B M O_{\nu}$, there exists $C>0$ such that

$$
\int_{\mathbb{R}}\left|I_{\gamma, b}^{+} f\right|^{q} w^{q} \leq C \int_{\mathbb{R}}|f|^{p} v^{p}
$$

for all bounded $f$ with compact support.
Finally we state the result for the commutator of $M_{\varphi_{\gamma}}^{+}$.
Theorem 2.3. Let $\gamma, p, q$ be such that $0<\gamma<1,1<p<\frac{1}{\gamma}$ and $\frac{1}{p}-\frac{1}{q}=\gamma$. Assume that $v \in A(p, q), w \in A^{+}(p, q)$ and $\nu=\frac{v}{w} \in A_{\infty}$. Then, for $b \in B M O_{\nu}$, there exists $C>0$ such that

$$
\int_{\mathbb{R}}\left|M_{\varphi_{\gamma}, b}^{+} f\right|^{q} w^{q} \leq C \int_{\mathbb{R}}|f|^{p} v^{p},
$$

for all bounded $f$ with compact support.
Remark 1. Observe that the results in [8] are absolutely different. In [8] we dealt with only one weight (this allowed us to give results for commutators of higher order). On the other hand, we can not obtained the results in [8] (for order $k=1$ ) from the present Theorems since we can not take $w=v$.

Remark 2. The results of Theorems 2.1, 2.2 and 2.3 for two-sided operators and related $A_{p}$ weights are due to Segovia and Torrea (see [18] and [19]). The improvement in our theorems for the corresponding one-sided operators is that we take into consideration a wider class of weights. By taking $w \in A_{p}^{+}$(or $w \in A^{+}(p, q)$ ), one improves not only on the left hand side of the inequality, but also on the right hand side. Notice the fact that $v=\nu^{p} w($ or $v=\nu w)$ gives

$$
\int_{\mathbb{R}}|f|^{p} v=\int_{\mathbb{R}}|f \nu|^{p} w \quad\left(\text { or } \quad \int_{\mathbb{R}}|f|^{p} v^{p}=\int_{\mathbb{R}}|f \nu|^{p} w^{p}\right) .
$$

An example that our class of weights is wider can be seen in [7].
Remark 3. Theorems 2.1 and 2.2 in [7], i.e., the same result of Theorem 2.1, for one-sided singular integrals and for the one-sided discrete square function instead of $M_{\varphi}^{+}$, can be obtained applying the extrapolation Theorem 1.1 and following the same pattern as in the proof of our Theorem 2.1.

Remark 4. Condition $b \in B M O_{\nu}$ is the natural one. Given $\nu \in A_{\infty}$, and assuming that there exists $w \in A_{p}^{+}$with $v=\nu^{p} w \in A_{p}$, then, by factorization, it can be proved that $\nu \in A_{2}^{-}$(see [11] and [20]). This fact, together with the doubling property for $\nu$, easily gives that $\nu \in A_{2}$. It can be proved that $b \in B M O_{\nu}$ is necessary to obtain the boundedness of $M_{b}^{+}$ and $M_{\gamma, b}^{+}, 0<\gamma<1$. We shall state and prove this claim for $M_{b}^{+}$. In a similar way the same result can be obtained for $M_{\gamma, b}^{+}$.

Theorem 2.4. Let $\nu \in A_{2}$ and $b \in L_{\text {loc }}^{1}(\mathbb{R})$. The following conditions are equivalent:
(i) $M_{b}^{+}$is bounded from $L^{p}(\alpha)$ to $L^{p}(\beta)$, for all $1<p<\infty, \alpha \in A_{p}$, $\beta \in A_{p}^{+}$such that $\left(\frac{\alpha}{\beta}\right)^{1 / p}=\nu$.
(ii) $M_{b}^{+}$is bounded from $L^{2}(\nu)$ to $L^{2}\left(\nu^{-1}\right)$.
(iii) $b \in B M O_{\nu}$.

Proof. (iii) $\Rightarrow(i)$ It is a consequence of Theorem 2.1.
$(i) \Rightarrow(i i)$ It is direct, by taking $p=2, \alpha=\nu \in A_{2}$ and $\beta=\nu^{-1} \in$ $A_{2} \subset A_{2}^{+}$.
(ii) $\Rightarrow$ (iii) Recall that $b \in B M O_{\nu}$ is equivalent to prove that there exists $C$ such that

$$
\frac{1}{\nu(I)} \int_{I}\left|b-b_{I^{+}}\right| \leq C
$$

for any bounded interval $I$. Fixed $I$, let $c$ be the right extreme of $I^{+}$. Then

$$
\begin{aligned}
\frac{1}{\nu(I)} \int_{I}\left|b(y)-b_{I^{+}}\right| d y & =\frac{1}{\nu(I)} \int_{I}\left|\frac{1}{\left|I^{+}\right|} \int_{I^{+}}(b(y)-b(x)) d x\right| d y \\
& \leq \frac{1}{\nu(I)} \int_{I} \frac{1}{\left|I^{+}\right|} \int_{I^{+}}|b(y)-b(x)| d x d y
\end{aligned}
$$

Observe that, for $y \in I$,

$$
\begin{aligned}
\frac{1}{\left|I^{+}\right|} \int_{I^{+}}|b(x)-b(y)| d x & =\frac{1}{\left|I^{+}\right|} \int_{y}^{c}|b(x)-b(y)| \chi_{I^{+}}(x) d x \\
& \leq C M_{b}^{+} \chi_{I^{+}}(y)
\end{aligned}
$$

Therefore, by Hölder's inequality, (ii) and the fact that $\nu$ is doubling,

$$
\begin{aligned}
\left.\frac{1}{\nu(I)} \int_{I} \right\rvert\, b(y) & -b_{I^{+}} \left\lvert\, d y \leq C \frac{1}{\nu(I)} \int_{I} M_{b}^{+} \chi_{I^{+}}(y) d y\right. \\
& \leq C \frac{1}{\nu(I)}\left(\int_{I}\left|M_{b}^{+} \chi_{I^{+}}(y)\right|^{2} \nu^{-1}(y) d y\right)^{1 / 2}\left(\int_{I} \nu\right)^{1 / 2} \\
& \leq C \frac{1}{\nu(I)}\left(\int_{\mathbb{R}}\left|\chi_{I^{+}}(y)\right|^{2} \nu(y) d y\right)^{1 / 2}\left(\int_{I} \nu\right)^{1 / 2} \\
& =\frac{1}{\nu(I)}\left(\int_{I^{+}} \nu\right)^{1 / 2}\left(\int_{I} \nu\right)^{1 / 2} \leq C .
\end{aligned}
$$

To prove the above theorems we also need the following lemmas. The first one can be found in [10].

Lemma 2.1. Let $w$ be a weight such that $w^{-1} \in A_{1}^{-}$. Then, there exists $\varepsilon>0$ such that, for all $1 \leq r \leq 1+\varepsilon, w^{-r} \in A_{1}^{-} \subset A_{r}^{-}$and $w^{r^{\prime}} \in A_{r^{\prime}}^{+}$.

Lemma 2.2. Assume $b \in B M O_{\nu}, x \in \mathbb{R}$ and $h>0$. For each $k \in \mathbb{Z}$, set $I_{k}=\left[x+2^{k} h, x+2^{k+1} h\right)$, and $J_{k}=\left[x, x+2^{k+1} h\right)$. Then for each $l \in \mathbb{Z}$ there exists $\delta>0$ such that,

$$
\left|b_{J_{l-1}}-b_{I_{k}}\right| \leq C \frac{2^{k(1-\delta)}}{\left|J_{k-1}\right|} \int_{J_{k-1}} \nu
$$

for all $k>l$.
Proof. Fix $l \in \mathbb{Z}$ and set $I=J_{l-1}$ for simplicity. First of all observe that

$$
\left|b_{I}-b_{I_{k}}\right| \leq\left|b_{I}-b_{I_{l}}\right|+\sum_{j=l}^{k-1}\left|b_{I_{j}}-b_{I_{j+1}}\right| .
$$

Since $b \in B M O_{\nu}$ we get

$$
\begin{aligned}
\left|b_{I}-b_{I_{l}}\right| & =\left|\frac{1}{|I|} \int_{I}\left(b(x)-b_{I_{l}}\right) d x\right| \\
& \leq \frac{1}{|I|} \int_{I}\left|b(x)-b_{I_{l}}\right| d x \leq C \frac{\nu(I)}{|I|} .
\end{aligned}
$$

Then, using that $\nu \in A_{\infty}$, there exists $\delta>0$ such that

$$
\begin{aligned}
\left|b_{I}-b_{I_{l}}\right| & \leq C \frac{\nu(I)}{\nu\left(J_{k-1}\right)} \frac{\left|J_{k-1}\right|}{|I|} \frac{1}{\left|J_{k-1}\right|} \int_{J_{k-1}} \nu \\
& \leq C\left(\frac{|I|}{\left|J_{k-1}\right|}\right)^{\delta} \frac{\left|J_{k-1}\right|}{|I|} \frac{1}{\left|J_{k-1}\right|} \int_{J_{k-1}} \nu \\
& =C\left(\frac{\left|J_{k-1}\right|}{|I|}\right)^{1-\delta} \frac{1}{\left|J_{k-1}\right|} \int_{J_{k-1}} \nu \\
& =C\left(\frac{2^{k}}{2^{l}}\right)^{1-\delta} \frac{1}{\left|J_{k-1}\right|} \int_{J_{k-1}} \nu \\
& \leq C \frac{2^{k(1-\delta)}}{\left|J_{k-1}\right|} \int_{J_{k-1}} \nu
\end{aligned}
$$

In the same way,

$$
\begin{aligned}
\sum_{j=l}^{k-1}\left|b_{I_{j}}-b_{I_{j+1}}\right| & \leq C \sum_{j=l}^{k-1} \frac{\nu\left(I_{j}\right)}{\left|I_{j}\right|} \\
& \leq C \sum_{j=l}^{k-1}\left(\frac{\left|J_{k-1}\right|}{\left|I_{j}\right|}\right)^{1-\delta} \frac{1}{\left|J_{k-1}\right|} \int_{J_{k-1}} \nu \\
& =C \sum_{j=l}^{k-1} \frac{\left(2^{1-\delta}\right)^{k-j}}{\left|J_{k-1}\right|} \int_{J_{k-1}} \nu \\
& \leq C \frac{2^{k(1-\delta)}}{\left|J_{k-1}\right|} \int_{J_{k-1}} \nu
\end{aligned}
$$

Lemma 2.3. Let $\nu \in A_{\infty}$. Assume that $\beta$ and $\alpha=\nu \beta$ are such that $\beta^{-1} \in A_{1}^{-}$and $\alpha^{-1} \in A_{1}$. Let $b \in B M O_{\nu}$. Then, there exists $\varepsilon>0$ such that, for all $1<r<1+\varepsilon$,

$$
\left(\frac{1}{|I|} \int_{I}\left|b-b_{I}\right|^{r} \alpha^{-r}\right)^{1 / r} \leq C \beta^{-1}(x), \text { a.e. } x \in I \cup I^{+} .
$$

Proof. Since $\beta^{-1} \in A_{1}^{-}$and $\alpha^{-1} \in A_{1}$, there exists $\varepsilon>0$ such that $\beta^{-r} \in A_{1}^{-}$and $\alpha^{-r} \in A_{1}$, for all $1<r<1+\varepsilon$. Let $s^{\prime}>1$ be such that $\alpha^{-r} \in R H_{s^{\prime}}$ (see [12] and [15] for definition). Then, by Hölder's and John-Nirenberg's inequalities (see Prop. 6, Chap. III in [21]), we have that

$$
\begin{align*}
\frac{1}{|I|} \int_{I}\left|b-b_{I}\right|^{r} \alpha^{-r} & \leq\left(\frac{1}{|I|} \int_{I}\left|b-b_{I}\right|^{r s}\right)^{\frac{1}{s}}\left(\frac{1}{|I|} \int_{I} \alpha^{-r s^{\prime}}\right)^{\frac{1}{s^{\prime}}}  \tag{2.1}\\
& \leq C\left(\frac{\nu(I)}{|I|}\right)^{r} \frac{1}{|I|} \int_{I} \alpha^{-r}
\end{align*}
$$

Using now that $\nu \in A_{\infty} \subset A_{\infty}^{+}, \alpha^{-r} \in A_{1} \subset A_{r} \subset A_{r}^{+}$and $\beta^{-r} \in A_{1}^{-}$, Hölder's inequality gives,

& \leq C \frac{1}{|I|} \int_{I^{+}} \beta^{-r} \leq C \beta^{-r}(x)

for almost every $x \in I \cup I^{+}$. Putting together inequalities (2.1) and (2.2) we get the desired result.

We now pass to prove the theorems of this section.

We will control $\left(M_{\varphi, b}^{+} f\right)_{\#,+}$ by sum of several one-sided maximal operators, which using Theorem 1.1, we shall prove that they are bounded from $L^{p}(v)$ to $L^{p}(w)$. Fix $x \in \mathbb{R}$ and $h>0$. Set $J=[x, x+8 h), \lambda=b_{J}$ and write $f=f_{1}+f_{2}$, where $f_{1}=f \chi_{J}$. Then

& \quad \quad+\frac{1}{h} \int_{x}^{x+2 h}\left|b(y)-b_{J}\right|\left|M_{\varphi}^{+} f(y)\right| d y \\
& = \\
& \quad I(x)+I I(x)+I I I(x) .
\end{aligned}

& \leq C\|f \alpha\|_{\infty} \sum_{j=3}^{\infty} \frac{2^{j+1}}{\left(2^{j}-2\right)^{2}}\left(\frac{1}{2^{j+1} h} \int_{I_{j}}\left|b(z)-b_{I_{j}}\right| \alpha^{-1}(z) d z\right. \\
& \left.\quad+\frac{1}{2^{j+1} h} \int_{I_{j}}\left|b_{I_{j}}-b_{J}\right| \alpha^{-1}(z) d z\right) \\
& =C\|f \alpha\|_{\infty} \sum_{j=3}^{\infty} \frac{2^{j+1}}{\left(2^{j}-2\right)^{2}}(I V(x)+V(x)) .

& \quad+\frac{1}{h} \int_{x}^{x+2 h}\left|b(y)-b_{J}\right|\left|I_{\gamma}^{+} f(y)\right| d y \\
& =I(x)+I I(x)+I I I(x) .

Let $\beta \in A^{+}\left(\frac{1}{\gamma}, \infty\right)$ and such that $\alpha=\nu \beta \in A(1 / \gamma, \infty)$. Then $\beta^{\frac{-1}{1-\gamma}} \in$ $A_{1}^{-}$and $\alpha^{\frac{-1}{1-\gamma}}=(\nu \beta)^{\frac{-1}{1-\gamma}} \in A_{1}$. Therefore, there exists $t_{1}>1$ with the properties that $\alpha^{\frac{-t_{1}}{1-\gamma}} \in A_{1}, s=\frac{t_{1}}{1-\gamma}>1$ and Lemma 2.3 holds for such $s$. & \leq C \sum_{j=3}^{\infty} \frac{h^{\gamma}}{\left(2^{j-1}\right)^{1-\gamma}}\left(\frac{2}{2^{j-1} h} \int_{I_{j}}\left|b(t)-b_{J}\right||f(t)| d t\right) \\

& \quad \times\left(\frac{2}{2^{j-1} h} \int_{I_{j}}\left|b(t)-b_{I_{j}}\right|^{\frac{1}{1-\gamma}} \alpha^{\frac{-1}{1-\gamma}}\right)^{1-\gamma}  \tag{2.17}\\
& \leq C\left(2^{j} h\right)^{-\gamma}| | f \alpha \|_{\frac{1}{\gamma}}\left(\frac{1}{2^{j} h} \int_{I_{j}}\left|b(t)-b_{I_{j}}\right|^{\frac{r}{1-\gamma}} \alpha^{\frac{-r}{1-\gamma}}\right)^{\frac{1-\gamma}{r}} \\
& \leq C\left(2^{j} h\right)^{-\gamma}\|f \alpha\|_{\frac{1}{\gamma}} \beta^{-1}(x) .
\end{align*}
$$

Using again Lemma 2.2 and Hölder's inequality,

$$
\begin{aligned}
V(x) & \leq \frac{1}{2^{j} h}\left|b_{I_{j}}-b_{J}\right| \int_{I_{j}}|f(t)| d t \\
& \leq C \frac{2^{j(1-\delta)}}{\left|J_{j-1}\right|} \int_{J_{j-1}} \nu\left(\frac{1}{2^{j} h} \int_{I_{j}}|f|^{\frac{1}{\gamma}} \alpha^{\frac{1}{\gamma}}\right)^{\gamma}\left(\frac{1}{2^{j} h} \int_{I_{j}} \alpha^{\frac{-1}{1-\gamma}}\right)^{1-\gamma} \\
& \leq\left. C 2^{j(1-\delta)}\left(2^{j} h\right)^{-\gamma}| | f \alpha\right|_{\frac{1}{\gamma}} \frac{1}{\left|J_{j-1}\right|} \int_{J_{j-1}} \nu\left(\frac{1}{2^{j} h} \int_{I_{j}} \alpha^{\frac{-1}{1-\gamma}}\right)^{1-\gamma}
\end{aligned}
$$

Since $\alpha^{\frac{-1}{1-\gamma}} \in A_{1} \subset A_{1}^{-}$,

$$
\frac{1}{2^{j} h} \int_{I_{j}} \alpha^{\frac{-1}{1-\gamma}} \leq C \alpha^{\frac{-1}{1-\gamma}}(y)
$$

for all $y \in J_{j-1}$. Then, using now that $\beta^{-1} \in A_{1}^{-}$,

$$
\begin{align*}
V(x) & \leq C 2^{j(1-\delta)}\left(2^{j} h\right)^{-\gamma} \|\left. f \alpha\right|_{\frac{1}{\gamma}} \frac{1}{\left|J_{j-1}\right|} \int_{J_{j-1}} \nu \alpha^{-1}  \tag{2.18}\\
& \leq C 2^{j(1-\delta)}\left(2^{j} h\right)^{-\gamma}\|f \alpha\|_{\frac{1}{\gamma}} \beta^{-1}(x)
\end{align*}
$$

Put together inequalities (2.16), (2.17) and (2.18), to get

$$
\begin{aligned}
& \quad \frac{1}{h} \int_{x}^{x+2 h}\left|\int_{x+8 h}^{\infty} \sigma(t, y) d t\right| d y \\
& \leq C\|f \alpha\|_{\frac{1}{\gamma}} \beta^{-1}(x) \sum_{j=3}^{\infty} \frac{h^{\gamma}}{\left(2^{j-1}\right)^{1-\gamma}}\left(\left(2^{j} h\right)^{-\gamma}+2^{j(1-\delta)}\left(2^{j} h\right)^{-\gamma}\right) \\
& \leq C\|f \alpha\|_{\frac{1}{\gamma}} \beta^{-1}(x) \sum_{j=3}^{\infty}\left(\frac{1}{2^{j}}+\frac{1}{2^{j \delta}}\right) \\
& \leq C\|f \alpha\|_{\frac{1}{\gamma}} \beta^{-1}(x)
\end{aligned}
$$

Taking supremum first on $h>0$ and then on $x \in \mathbb{R}$, get,

$$
\left\|\beta M_{5}^{+} f\right\|_{\infty} \leq C\|f \alpha\|_{\frac{1}{\gamma}}
$$

So, by Theorem 1.2,

$$
\left\|M_{5}^{+} f\right\|_{L^{q}\left(w^{q}\right)} \leq C\|f\|_{L^{p}\left(v^{p}\right)}
$$

whenever $w \in A^{+}(p, q)$ and $v=\nu w \in A(p, q), \frac{1}{p}-\frac{1}{q}=\gamma$ and $f \in$ $\mathcal{C}_{c}^{\infty}(\mathbb{R})$.

The proof of Theorem 2.3 follows the same pattern as Theorem 2.2, so we omit it.

## 3. Proof of the Extrapolation Theorems

To prove our results on extrapolation, we need the following lemma (see [16] and [18]).
Lemma 3.1. Let $\mu$ be a weight, and let $1<r<\infty$. Let $W \in A_{r}^{-}$, such that $\mu^{r} W \in A_{r}$. Then, for all $u \in L^{r^{\prime}}(W)$, there exists $U \in L^{r^{\prime}}(W)$ such that
(i) $u(x) \leq U(x)$, a.e.
(ii) $\|U\|_{L^{r^{\prime}}(W)} \leq C\|u\|_{L^{r^{\prime}}(W)}$,
(iii) $U W \in A_{1}^{-}$and $U \mu W \in A_{1}$.

Proof. Define first the following operator

$$
S(h)=W^{-1} M^{+}(W h)+(\mu W)^{-1} M(\mu W h) .
$$

We claim that this operator is bounded from $L^{r^{\prime}}(W)$ to $L^{r^{\prime}}(W)$. Indeed, observe that $W \in A_{r}^{-}$if, and only if, $W^{1-r^{\prime}} \in A_{r^{\prime}}^{+}$. Then $M^{+}$ is bounded from $L^{r^{\prime}}\left(W^{1-r^{\prime}}\right)$ to $L^{r^{\prime}}\left(W^{1-r^{\prime}}\right)$. Also, $\mu^{r} W \in A_{r}$ implies that $\left(\mu^{r} W\right)^{1-r^{\prime}}=\mu^{-r^{\prime}} W^{1-r^{\prime}} \in A_{r^{\prime}}$. Therefore $M$ is bounded from $L^{r^{\prime}}\left(\mu^{-r^{\prime}} W^{1-r^{\prime}}\right)$ to $L^{r^{\prime}}\left(\mu^{-r^{\prime}} W^{1-r^{\prime}}\right)$. As a consequence,

$$
\begin{aligned}
\int(S(h))^{r^{\prime}} W & \leq C \int W^{-r^{\prime}}\left(M^{+}(W h)\right)^{r^{\prime}} W+C \int(\mu W)^{-r^{\prime}}(M(\mu W h))^{r^{\prime}} W \\
& =C \int\left(M^{+}(W h)\right)^{r^{\prime}} W^{1-r^{\prime}}+C \int(M(\mu W h))^{r^{\prime}} \mu^{-r^{\prime}} W^{1-r^{\prime}} \\
& \leq C \int(W h)^{r^{\prime}} W^{1-r^{\prime}}+C \int(\mu W h)^{r^{\prime}} \mu^{-r^{\prime}} W^{1-r^{\prime}} \\
& =C \int|h|^{r^{\prime}} W
\end{aligned}
$$

Then, by lemma 5.1 in [4], given $u \in L^{r^{\prime}}(W)$, there exists $U \in L^{r^{\prime}}(W)$ such that $\|U\|_{L^{r^{\prime}}(W)} \leq 2\|u\|_{L^{r^{\prime}}(W)}, U(x) \geq u(x)$ and $S(U)(x) \leq C U(x)$ a.e. $x \in \mathbb{R}$. Then

$$
W^{-1} M^{+}(W U)(x) \leq C U(x) \text { and }(\mu W)^{-1} M^{+}(\nu W U)(x) \leq C U(x)
$$

a.e. $x \in \mathbb{R}$. In other words, $W U \in A_{1}^{-}$and $\mu W U \in A_{1}$.

Proof of Theorem 1.1. Fix $w \in A_{p}^{+}$, such that $v=\nu^{p} w \in A_{p}$. Let $f \in$ $L^{p}(v)$ and consider

$$
g(x)= \begin{cases}\frac{w^{-\frac{1-p^{\prime}}{p}}(x)|f(x)| \nu(x) w^{1 / p}(x)}{\|f\|_{L^{p}}(v)}, & \text { if } f(x) \neq 0 \\ w^{-\frac{1-p^{\prime}}{p}}(x) e^{-\frac{\pi x^{2}}{p}}, & \text { if } f(x)=0\end{cases}
$$

Observe that $g \in L^{p}\left(w^{1-p^{\prime}}\right)$ and $\|g\|_{L^{p}\left(w^{1-p^{\prime}}\right)} \leq 2$. On the other hand, $w^{1-p^{\prime}} \in A_{p^{\prime}}^{-}$and $\nu^{-p^{\prime}} w^{1-p^{\prime}} \in A_{p^{\prime}}$. Then, by Lemma 3.1, there exists $G \in L^{p}\left(w^{1-p^{\prime}}\right)$, such that
(i) $g(x) \leq G(x)$, a.e.
(ii) $\|G\|_{L^{p}\left(w^{1-p^{\prime}}\right)} \leq C\|g\|_{L^{p}\left(w^{1-p^{\prime}}\right)}$,
(iii) $G w^{1-p^{\prime}} \in A_{1}^{-}$and $G \nu^{-1} w^{1-p^{\prime}} \in A_{1}$.

Let $\beta=\left(G w^{1-p^{\prime}}\right)^{-1}$. Then $\beta^{-1} \in A_{1}^{-}$and, defining $\alpha=\nu \beta$, we also have $\alpha^{-1}=(\nu \beta)^{-1} \in A_{1}$ and

$$
\|\beta T f\|_{\infty} \leq C\|f \alpha\|_{\infty}
$$

So,

$$
\begin{aligned}
\|f\|_{L^{p}(v)} & =\left\|g^{-1} w^{-\frac{1-p^{\prime}}{p}}|f| v^{\frac{1}{p}}\right\|_{\infty} \\
& \geq\left\|G^{-1} w^{-\frac{1-p^{\prime}}{p}}|f| \nu w^{\frac{1}{p}}\right\|_{\infty} \\
& =\left\|\left(G w^{1-p^{\prime}}\right)^{-1} \nu|f|\right\|_{\infty}=\|f \alpha\|_{\infty} \\
& \geq C\|\beta T f\|_{\infty}=C\left\|G^{-1} w^{p^{\prime}-1} T f\right\|_{\infty} \\
& \geq C\left(\int G^{p} w^{1-p^{\prime}}\right)^{1 / p}\left\|G^{-1} w^{p^{\prime}-1} T f\right\|_{\infty} \\
& \geq C\left(\int G^{-p} w^{p\left(p^{\prime}-1\right)}|T f|^{p} G^{p} w^{1-p^{\prime}}\right)^{1 / p} \\
& =C\|T f\|_{L^{p}(w)} .
\end{aligned}
$$

Proof of Theorem 1.2. Fix $1<p<p_{0}, q$ such that $\frac{1}{p}-\frac{1}{q}=\frac{1}{p_{0}}$ and $w \in A^{+}(p, q)$ such that $v=\nu w \in A(p, q)$. Observe that, for $r=1+q / p^{\prime}$ and $s=1+p^{\prime} / q\left(s^{\prime}=q / p_{0}^{\prime}\right)$, we have that $w^{q} \in A_{r}^{+}, v^{q} \in A_{r}, w^{-p^{\prime}} \in A_{s}^{-}$ and $v^{-p^{\prime}}=\nu^{-p^{\prime}} w^{-p^{\prime}} \in A_{s}$. Let $f \in L^{p}\left(v^{p}\right)$ and consider

$$
h(x)=\left(\frac{|f(x)| \nu(x) w^{p^{\prime}}(x)}{\|f\|_{L^{p}\left(v^{p}\right)}}\right)^{\frac{p p_{0}^{\prime}}{q}} .
$$

Observe that $h \in L^{s^{\prime}}\left(w^{-p^{\prime}}\right)$. In fact $\|h\|_{L^{s^{\prime}}\left(w^{-p^{\prime}}\right)}=1$. Therefore, by Lemma 3.1, there exists $H \in L^{s^{\prime}}\left(w^{-p^{\prime}}\right)$ such that
(i) $h(x) \leq H(x)$, a.e.
(ii) $\|H\|_{L^{s^{\prime}}\left(w^{-p^{\prime}}\right)} \leq C\|h\|_{L^{s^{\prime}}\left(w^{-p^{\prime}}\right)}=1$,
(iii) $H w^{-p^{\prime}} \in A_{1}^{-}$and $H \nu^{\frac{-p^{\prime}}{s}} w^{-p^{\prime}} \in A_{1}$.

Let $\beta=\left(H w^{-p^{\prime}}\right)^{-\frac{1}{p_{0}^{\prime}}}$ and consider $\alpha=\nu \beta$. Then $\beta \in A^{+}\left(p_{0}, \infty\right)$ and $\alpha \in A\left(p_{0}, \infty\right)$. As a consequence,

$$
\begin{aligned}
\|f\|_{L^{p}\left(v^{p}\right)} & =\left(\int|f|^{p_{0}}\left(h^{-1 / p_{0}^{\prime}} \nu w^{p^{\prime} / p_{0}^{\prime}}\right)^{p_{0}}\right)^{1 / p_{0}} \\
& \geq\left(\int|f|^{p_{0}}\left(H^{-1 / p_{0}^{\prime}} \nu w^{p^{\prime} / p_{0}^{\prime}}\right)^{p_{0}}\right)^{1 / p_{0}} \\
& =\|f\|_{L^{p_{0}\left(\alpha^{p_{0}}\right)} \geq} \geq C\|\beta T f\|_{\infty} \\
& =C\left\|T f H^{-1 / p_{0}^{\prime}} w^{p^{\prime} / p_{0}^{\prime}}\right\|_{\infty} \\
& \geq C\left\|T f H^{-1 / p_{0}^{\prime}} w^{p^{\prime} / p_{0}^{\prime}}\right\|_{\infty}\left(\int H^{q / p_{0}^{\prime}} w^{-p^{\prime}}\right)^{1 / q}
\end{aligned}
$$

$$
\begin{aligned}
& \geq C\left(\int|T f|^{q} H^{-q / p_{0}^{\prime}} w^{q p^{\prime} / p_{0}^{\prime}} H^{q / p_{0}^{\prime}} w^{-p^{\prime}}\right)^{1 / q} \\
& =C\|T f\|_{L^{q}\left(w^{q}\right)} .
\end{aligned}
$$
